## **Duty of Care Policy**

#### Background

At Huntingdale Primary School we understand our duty of care and that teachers are required to supervise all learning environments that students are working in- the school grounds, classroom and online spaces as well as excursions and camps.

#### Purpose

The purpose of this policy is to:

- Explain to our school community the non-delegable duty of care obligations that all staff at Huntingdale Primary School owe to our students and members of the school community who visit and use the school premises.
- Ensure Huntingdale Primary School is compliant with Department of Education and Training's (DET) policies and procedures and the Child Safe Standards.
- Maintain the DE values of leadership, respect, responsiveness, human rights, integrity, impartiality and accountability.

#### Implementation

"Duty of care" is a legal obligation that requires schools to take reasonable steps to reduce the risk of reasonably foreseeable harm, which can include personal injury (physical or psychological) or damage to property. The reasonable steps that our school may decide to take in response to a potential risk or hazard will depend on the circumstances of the risk.

Our school has developed policies and procedures to manage common risks in the school environment, including:

- Student Engagement
- Child Safety Responding and Reporting Obligations Policy and Procedure
- Child Safety Code of Conduct
- Camps, Excursions and In School Visits
- First Aid and Health Care
- Asthma

- Photographing filming and recording students
- Personal Property

Our school acknowledges we are required to take reasonable precautions to prevent the abuse of a child by an individual associated with the organisation while the child is under the care, supervision or authority of the organisation.

Staff at our school understand that school activities involve different levels of risk and that particular care may need to be taken to support younger students or students with additional needs. Our school also understands that it is responsible for ensuring that the school premises are kept in good repair and will take reasonable steps to reduce the risk of members of our community suffering injury or damage because of the state of the premises.

School staff, parents, carers and students are encouraged to speak to the principal to raise any concerns about risks or hazards at our school, or our duty of care obligations.

#### **External Providers**

Staff at our school acknowledge that, as our duty of care is non-delegable, we are also required to take reasonable steps to reduce the risk of reasonably foreseeable harm when external providers have been engaged to plan for or conduct an activity involving our students. Our *Visitors Policy* and *Camps and Excursions Policy* include information on the safety and care of our students when engaged with external providers.

#### Communication

This policy will be communicated to our school community in the following ways:

- Provided to staff at induction and included in staff handbook
- Discussed at staff meetings workshops as required
- Made available publicly on our school website
- Made available in hard copy from school administration upon request
