

Health Care Needs Policy

BACKGROUND

As part of being a government school, Huntingdale Primary School has a responsibility to provide equitable access to education and respond to diverse student needs, including health care needs.

PURPOSE

To ensure that Huntingdale Primary School:

- Provides appropriate support to students with health care needs.
- Explains to parents, carers, staff and students the processes and procedures in place to support students with health care needs at school.
- Follow DE's Values of Accountability, Human Rights, Impartiality, Integrity, Leadership, Respect and Responsiveness

SCOPE

This policy applies to:

- All staff, including casual relief staff and volunteers
- All students who have been diagnosed with a health care need that may require support, monitoring or medication at school.

POLICY

- This policy should be read with Huntingdale Primary School's *First Aid, Administration of Medication, Anaphylaxis* and *Asthma* policies.

Student health support planning

- In order to provide appropriate support to students at Huntingdale Primary School who may need medical care or assistance, a Student Health Support Plan will be prepared by the Assistant Principal with the assistance of other key staff (First Aid Leader, ES Leader and/or Student Wellbeing Coordinator) in consultation with the student, their parents, carers and treating medical practitioners.
- Student Health Support plans help our school to assist students with:
 - Routine health care support needs, such as supervision or provision of medication
 - personal care support needs, such as assistance with personal hygiene, continence care, eating and drinking, transfers and positioning, and use of health-related equipment
 - Emergency care needs, such as predictable emergency first aid associated with asthma, seizure or diabetes management.
- Students with complex medical care needs, for example, tracheostomy care, seizure management or tube feeding, must have a Student Health Support Plan which provides for appropriate staff to undertake specific training to meet the student's particular needs.
- At enrolment or when a health care need is identified, parents/carers should provide accurate information about the student's condition or health care needs, ideally documented by the student's treating medical/health care practitioner on a Medical Advice Form (or relevant equivalent).

- Huntingdale Primary School may invite parents and carers to attend a Student Support Group meeting to discuss the contents of a student’s Health Support Plan and assistance that the student may need at school or during school activities.
- Where necessary, Huntingdale Primary School may also request consent from parents and carers to consult with a student’s medical practitioners, to assist in preparing the plan and ensure that appropriate staff understand the student’s needs. Consultation with the student’s medical practitioner will not occur without parent/carer consent unless required or authorised by law.

- Student Health Support Plans will be reviewed:
 - when updated information is received from the student’s medical practitioner
 - when the school, student or parents and carers have concerns with the support being provided to the student
 - if there are changes to the support being provided to the student, or
 - on an annual basis.

Management of confidential medical information

- Confidential medical information provided to Huntingdale Primary School to support a student will be:
 - recorded on the student’s file
 - shared with all relevant staff so that they are able to properly support students diagnosed with medical conditions and respond appropriately if necessary.

- Available publicly on our school’s website
- Included in the staff ‘Key Documents Folder’ on Google Drive
- Discussed at staff briefings/meetings as required
- Reminders in our school newsletter
- Hard copy available from school administration upon request
